Re: Funding Distribution 2010-2011

Please find the attached WRN annual funding distribution for 2010-2011.

- b. WRN affirms a shared 2010-2011 Internet2 network subscription based on the following location/port approach:
 - a. PNWGP as I2 Connector Seattle / 1 x 10gb
 - b. CENIC as I2 Connector Los Angeles / 1 x 10gb
 - c. CENIC as I2 Connector Kansas City / 1 x 10gb
- c. WRN affirms member commitment to general cost sharing;
- d. WRN affirms WRN member annual use of existing network segments (birthrights, leased services, etc.);
- e. WRN agrees to route traffic Internet2 and NLR as authorized by the respective organizations;
- f. WRN agrees to inform members about Internet2 SEGP memberships. Any SEGP fees would be invoiced by the appropriate Internet2 connector unless Internet2 specifies otherwise.

An email vote by the WPC will be held between June 16, 2010 and June 17, 2010.
